

Verify your eligibility for FirstNet[®] service within 30 days

We look forward to having you as a customer and invite you to verify your eligibility for FirstNet service.

Next steps: To verify your eligibility as soon as possible, please submit the required documents to firstnet.com/verify. Below you can find the appropriate documents and job titles required to complete verification. All FirstNet customers **must verify eligibility**. Only the job titles listed in this document are eligible for FirstNet service. Other job titles are not eligible, will not pass verification, and will be offboarded from FirstNet. Please note: you will need your FirstNet profile and password to upload documentation.

First Responders

ID badges or paystubs are the best eligibility documentation to submit. IDs and paystubs **must have name and agency listed**. Only one document type is required. Business cards are not acceptable. Training certificates of completion are not acceptable.

Healthcare / Hospital

A medical license is the best eligibility document to submit to specify medical role. An ID badge or paystub can be submitted, but this **MUST** include your name and job title to be accepted. Certifications of class type completions are not eligible (diplomas, first aid/CPR, BLS, Training/Seminars).

Air / Army National Guard

Military leave, earnings statement or official letter are the best eligibility documentation to submit. They must include your name and agency name. CAC Cards are not an acceptable form of identification for National guard.

Military – Public Safety

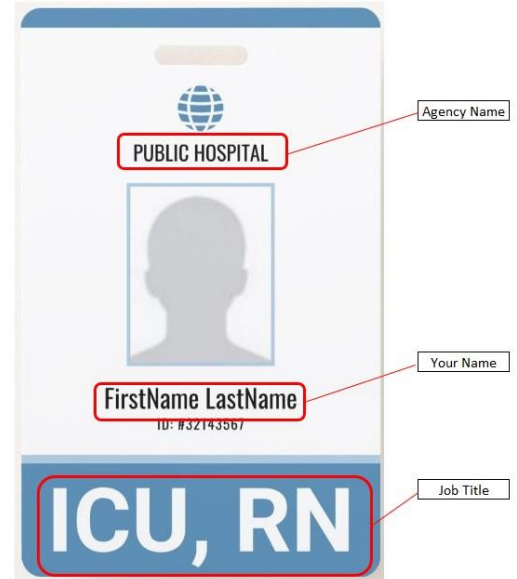
Military leave, earnings statement or official letter are the best eligibility documentation to submit. They must include your name, agency name, and specify EMT / Paramedic / Fire or Police. Please note reservists are not eligible.

Government - Utility Field Technician

ID badges or paystubs are the best eligibility documentation to submit. Only Field Technicians at Utilities are eligible for FirstNet service. IDs and paystubs must include your name, job title and agency name. Only one document type is required.

Please Note: Business cards are not acceptable. Training certificates of completion are not acceptable.
